4) Health Condition

All participants must ensure that they are in good health and not suffering from any condition which may render them not recommendable for participating in this race. Participants are advised to undertake adequate training and to consult medical advice from doctors if they are in doubt of their health condition prior to taking part in the race.

5) Waiver – to be signed by each participant in the team

In consideration of being allowed to participate in the services and Activities, including, but not limited to, water polo, swimming, diving, ball throwing, and any other amusement activities (collectively “Activities”), organized by HONG KONG BEACH WATER POLO ASSOCIATION LIMITED and its agents, owners, officers, directors, principals, volunteers, participants, clients, customers, invitees, employees, independent contractors, insurers, facility operators, and any and all other persons and entities acting in any capacity on its behalf (collectively “HKBWPAL”), I, on behalf of myself, and/or on behalf of my minor child(ren)/ward(s), hereby agree to forever release, indemnify, and discharge HKBWPAL on behalf of myself, my spouse, legal partner, my children, my parents, my guardians, heirs, assigns, personal representatives and estate, and all other persons and entities who could in any way represent me or act on my behalf as follows:

(1) RELEASE OF LIABILITY: Despite all known and unknown risks, I hereby expressly and voluntarily remise, release, acquit, satisfy, and forever discharge HKBWPAL and agree to hold it harmless of and from all, and all manner of action and actions or omission(s), cause and cause of action, suits, debts, dues, sums of money, accounts, reckonings, bonds, bills, specialties, covenants, contracts, controversies, agreement, promises, variances, trespasses, damages, judgments, executions, claims, and demands whatsoever, in law or in equity, including, but not limited to, any and all claims which allege negligent acts and/or omissions committed by HKBWPAL, whether the action arises out of any damage, loss, personal injury, or death to me or my child(ren)/ward(s), while participating in or as a result of participating in any of the Activities. This Release of Liability is effective and valid regardless of whether the damage, loss, personal injury, or death is a result of any act or omission on the part of HKBWPAL.

(2) INDEMNIFICATION: I hereby agree to indemnify and hold harmless from and against any and all losses, liabilities, claims, obligations, costs, damages and/or expenses whatsoever paid, incurred and/or suffered by HKBWPAL, including, but not limited to, any and all attorneys’ fees, costs, damages, and/or judgments HKBWPAL incurs in the event that I or my minor child(ren)/ward(s) cause any injury, damage, and/or harm to HKBWPAL and/or any and all other persons and entities acting in any capacity on behalf of HKBWPAL.

(3) ATTORNEYS’ FEES: I promise to indemnify HKBWPAL for any attorneys’ fees and/or costs incurred to enforce this agreement, including all costs associated with any collection efforts. Further, should any debt and/or judgment accrue in favor of HKBWPAL, pre-judgment and post-judgment interest shall accrue thereon at a rate of 18% per annum.

(4) MEDIA RELEASE: By participating in Activities organized by HKBWPAL, I hereby grant HKBWPAL, on behalf of myself and on behalf of my child(ren)/ward(s), the irrevocable right and permission to photograph and/or record me or my child(ren)/ward(s) in connection with HKBWPAL and to use the photograph and/or recording for all purposes, including advertising and promotional purposes, in any manner and all media now or hereafter known, in

perpetuity throughout the world, without restriction as to alteration. I waive any right to inspect or approve the use of the photograph and/or recording, and acknowledge and agree that the rights granted to this release are without compensation of any kind.

(5) VENUE/GOVERNING LAW: I agree that this agreement shall be governed by the laws of Hong Kong Special Administrative Region (“HKSAR”) and I hereby submit to the exclusive jurisdiction of the courts of the HKSAR with respect to all matters relating to this agreement. By signing this document, I understand that I may be found by a court of law to have forever waived my and my child(ren)/ward(s) right to maintain any action against HKBWPAL on the basis of any claim from which I have released HKBWPAL and any released party herein. I have had a reasonable and sufficient opportunity to read and understand this entire document and consult with legal counsel, or have voluntarily waived my right to do so. I knowingly and voluntarily agree to be bound by all terms and conditions set forth herein.
